Post-Natal Depression Essay Competition

You are invited to submit, in open competition, an essay on Post-Natal Depression and the influence of the cultural context and cultural practices on evolving knowledge. The essay should give an incisive and synoptic synthesis of the world literature, focussing on improving knowledge about the ethno-aetiology of Post-Natal Depression and its implications for practice. The prize is open for all people from any organisation and professional discipline that has engaged with issues of Post-Natal Depression and culture. Three prizes will be awarded by a panel of experts. Entries must be no more than 5000 words, and must be referenced using the Harvard reference style, and submitted by email to pndessay@careif.org by 1st December 2011.

Consensus Document on European Brain Research

The European Journal of Neuroscience is publishing the 2011 version of the Consensus Document on European Brain Research (EJN, Vol. 33, pp. 768–818, 2011). The Consensus document, prepared by European Brain Council in collaboration with more than 200 European scientists and patients organizations, contains both proposals for future research programmes and describes the needs and achievements of research in Europe. The document highlights the need for strong basic research in neuroscience and the development of a strong European platform for brain research which is needed to address brain diseases, representing nowadays a societal emergency in European countries.
