### 2024 Annual Report WPA Digital Mental Health Section

#### Overview

In 2024, the WPA Digital Mental Health (DMH) Section undertook various initiatives to strengthen collaboration, promote research, and support education in the domain of digital psychiatry. Key activities included regular virtual meetings, formation of specialised working groups, preparation of international symposia, and planning for future congresses and webinars.

### **Key Highlights**

# 1. Section Meetings

Three official online meetings were held in March, July, and December 2024. Each meeting served as a platform for strategic planning, project updates, and international collaboration.

#### March 2024 Meeting

- Election of meeting date via Doodle poll to maximise participation.
- Reviewed symposium proposals for the World Congress of Psychiatry.
- Discussed a potential joint symposium with the WPA Section of Addiction Psychiatry.
- Evaluated, but ultimately did not proceed with, a European project on **Artificial Intelligence**.
- Finalised a plan to form **four working groups**: Artificial Intelligence, Telepsychiatry, Mobile Apps, and Ethics & Education.

#### July 2024 Meeting

- 23 members participated in a survey to join working groups.
- Decision to host one webinar per working group annually, each in a separate quarter.
- Tentative webinar schedule established starting in October 2024.
- Member selection and open call for further participation.

#### **December 2024 Meeting**

- Discussed participation in the WPA Regional Congress (April 2025, Egypt).
- Reviewed a proposal for involvement in the Colombo Congress, Feb 2025.
- Explored the feasibility of organizing a thematic congress.
- Updates on upcoming webinars by the AI and Ethics & Education groups.
- Progress on Al and Mobile Apps Guideline development.
- Engaged in a discussion regarding Australia's plan to ban social media for minors.

The DMH Section successfully formed four specialised working groups. Members were encouraged to volunteer and choose their preferred group.

- Planning webinar for June 2025.

#### 2.3 Telepsychiatry

- Plans are underway for a future webinar in the third quarter of 2025.
